* **Discussion regarding the City’s Proposed Restaurant Beverage Program**

The proposed Restaurant Beverage Program (RBP) would create an administrative clearance process for alcohol service at sit-down restaurants. The new ordinance would shorten the processing time and lower the cost of obtaining a Conditional Use Permit to serve alcoholic beverages for certain types of sit-down restaurants. This initiative from City Planning is designed to reduce delays, uncertainty, and permitting costs for businesses while maintaining operating standards, monitoring/enforcement procedures, and other neighborhood protections. A public hearing will be scheduled soon, potentially as early as June, 2020. – DISCUSSION AND POSSIBLE ACTION

* **Discussion regarding upcoming land use cases in UNNC boundaries**

The City Planning Department is continuing to process Project Applications during the COVID-19 state of emergency, and therefore UNNC has been receiving land use entitlement applications for projects within the UNNC footprint. Brief discussion about these pending cases and how to schedule them for the UNNC Planning & Zoning Committee’s upcoming virtual meetings. – DISCUSSION

* **Update RE: DIR-2020-2205-SPP, 3101 West Exposition Blvd., 3625-3637 S. 11th Avenue (former dairy manufacturing and distribution center)**

This property is being rehabbed as an Adaptive Reuse project, changing from the former dairy to a corporate headquarters complex. Some of the project is “by right” but part of the project falls under the Crenshaw Specific Plan and requires a Planning Department approval. Project description: Demolition of existing truck receiving area and accessory roof structure for construction of a 4-story, 60-foot tall, office building with one level of subterranean parking and 29,389 sq ft of floor area. – DISCUSSION AND POSSIBLE ACTION

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the CA is a telemarketer. If you hear, "Hello. This is the relay service . . ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. If you have limitations hearing or speaking a specially-trained

Communications Assistant (CA) can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.
