- 3). **“Building A Safer Los Angeles,” Council File No. 19-0603:**

The Los Angeles City Council recently voted to have City staff from the Fire Department, Building & Safety, and the Planning Department explore a proposal which would curtail the use of wood-frame construction for larger developments in some of its most densely-populated neighborhoods, billed as an attempt to reduce the city's vulnerability to wildfires. The report back, based on a recommendation from the Council's Public Safety Committee, could support an expansion of the City's Fire District 1 (high fire hazard areas) to apply to all projects consisting of at least 150,000 square feet of floor area; or projects with as little as 100,000 square feet of floor area if the building would be more than 30 feet in height; and/or to projects in neighborhoods with population density of more than 5,000 residents per square mile.

The proposal, which was initiated by a motion introduced by City Councilmembers Bob Blumenfield and Monica Rodriguez, is backed by an organization called Build with Strength. The support campaign is led by the National Ready Mixed Concrete Association. Conversely, some housing advocates argue that the goals of the proposal are at odds with the City's efforts to increase its supply of housing, especially questioning whether expanding Fire District 1 would impact the city's ability to produce new affordable housing. In addition to potential cost increases resulting from the inability to use wood-frame construction, the more stringent code requirements of Fire District 1 may prevent projects from taking advantage of certain incentives granted under the Transit Oriented Communities guidelines. The non-profit Abundant Housing LA argues that the "measure would worsen the City's housing and homelessness crises and undermine our climate change mitigation goals."

The City departments have been requested to report back within “30 days.” This agenda item may result in the UNNC Planning and Zoning Committee making a recommendation to the UNNC Governing Board to take a position, and/or having the Committee prepare a draft Resolution or Community Impact Statement (CIS) on this motion and report. – **DISCUSSION AND POSSIBLE ACTION**

Please note: All UNNC stakeholders are invited to participate in UNNC Standing Committee meetings. UNNC's Governing Board appoints Committee Chairs and Co-Chairs annually; these positions are open to all stakeholders. Per UNNC practice and policy, all stakeholders present at a Standing Committee meeting, including members of UNNC's Governing Board, are considered to be members of that committee for the duration of that meeting, and may equally participate, including by making motions and voting. Any action taken at the meeting is only a recommendation to the Governing Board; no Standing Committee may act on behalf of the Governing Board without prior authorization. UNNC's Governing Board members may be in attendance at its Standing Committee meetings as participants or observers. Per the California Open Meetings Act ("The Ralph M. Brown Act"), in accordance with Government Code Chapter 9 / meetings [54950 - 54963], Section 54952 (b), UNNC's Standing Committees are "legislative bodies" for the purposes of this Chapter. And, in accordance with Section 54952.2. (c) (6), nothing in this section prevents the attendance of a majority of the members of a legislative body at an open and noticed meeting of a standing committee of that body.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers - generally telephone companies - are compensated for the costs of providing TRS from either a state or a

federal fund. There is no cost to the TRS user. What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service .. ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.

CRS CAs do not participate in the conversation and acquire no benefit from information relayed.
