### 3). **Council File 21-0065: Ghost Kitchens, Co-Living Residences (Citywide)**

Review of Motion, which asks the Planning Department, Building & Safety and the City Attorney to draft an ordinance to define Ghost Kitchens and, separately, Co-Living Residences. Per the motion, "There are land uses that are not defined in the Municipal Code because up until recently they did not exist as part of our economy" but "are part of new business models in response to consumer demand. These uses do not currently fall into any of the existing uses enumerated in the Municipal Code, and ... there are no corresponding zones of the City where they are allowed to locate."

#### **Background:**

Ghost kitchens, per the motion, "are a new emerging business model in response to the demand for delivery meals, and the rising usage of third-party delivery applications, and ultimately, because of the lower costs incurred by using kitchen facilities located outside of high-rent neighborhoods." However, because there is no definition, there are also no requirements for parking or delivery zones, nor hours of operations.

"Co-living residential arrangements....are dwellings that pack in large number of unrelated residents. Again, this is a new use currently undefined in the Municipal Code— it has evolved... in response to consumer demands, and as a result of the scarcity of affordable housing, particularly in large and medium-sized cities; and especially so in Los Angeles where approximately 60 percent of its residents are renters." But there are no corresponding zones in which they may be built, no parking requirements specific to the use, and no other regulations at this time. – **DISCUSSION AND POSSIBLE ACTION**

### 4.) **City Planning Commission Follow-Up to “Equity Day” – Review of CPC and Planning Department Presentations Regarding How Structural Racism Affects the Planning Process:**

The Los Angeles City Planning Commission (CPC) held an “Equity Day” discussion in January, 2021, and then convened a second public discussion on June 21, 2021 to begin to address prior public comments, many specifically focused on Structural Racism within the Planning Process. The UNNC Planning & Zoning Committee will review the two presentations (CPC and Planning Staff), followed by a discussion focused on our own community. – **PRESENTATION AND DISCUSSION**

**Please note:** All UNNC stakeholders are invited to participate in UNNC Standing Committee meetings. UNNC's Governing Board appoints Committee Chairs and Co-Chairs annually; these positions are open to all stakeholders. Per UNNC practice and policy, all stakeholders present at a Standing Committee meeting, including members of UNNC's Governing Board, are considered to be members of that committee for the duration of that meeting, and may equally participate, including by making motions and voting. Any action taken at the meeting is only a recommendation to the Governing Board; no Standing Committee may act on behalf of the Governing Board without prior authorization. UNNC's Governing Board members may be in attendance at its Standing Committee meetings as participants or observers. Per the California Open Meetings Act ("The Ralph M. Brown Act"), in accordance with Government Code Chapter 9 / meetings [54950 - 54963], Section 54952 (b), UNNC's Standing Committees are "legislative bodies" for the purposes of this Chapter. And, in accordance with Section 54952.2. (c) (6), nothing in this section prevents the attendance of a majority of the members of a legislative body at an open and noticed meeting of a standing committee of that body.

## **Telecommunication Relay Services**

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service . . ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.

No part of the conversation that takes place between callers is revealed or recorded in written, verbal, or any other form. CRS CAs do not participate in the conversation and acquire no benefit from information relayed.
