### AGENDA

- 1). **Determination to continue to hold meetings virtually:** *The Board of Neighborhood Commissioners (BONC) and the Department of Neighborhood Empowerment, with guidance from the Los Angeles City Attorney, have established that BONC has the authority to adopt AB 361 Findings Pursuant to Government Code Section 54953(E)(1)(b)-(c) on behalf of the City's neighborhood councils, and to determine that due to the Covid-19 state of emergency, meeting in person would present imminent risks to the health or safety of attendees. This meeting is being conducted virtually pursuant to that directive.*
- 2). **Welcome & Call to Order; Review of UNNC Standing Rules for Committee Stakeholder Voting Participation; Introductions and Voting Affirmations; Review of the Agenda**
- 3). **Public Comments** (1-2 minutes per speaker)
- 4). **Digital Kiosks on Washington Boulevard between Arlington and La Brea:** Discussion and possible action regarding the “Digital Ad Kiosks” (or “Interactive Kiosk Experience”) proposed for Washington Blvd. by the Mayor’s Office and the City’s Tourism Board. Kiosks will be owned and managed by the private media company IKE Smart City. The City Council is bringing this item up for a vote as early as this week. There has been no outreach to Neighborhood Councils to date for a program that may have a significant affect (positive or negative) on one of UNNC’s major boulevards. – **DISCUSSION AND ACTION**
- 5). **“Livable Communities Initiative” proposed for “transit-rich corridors,” per Program 131 of the City’s recently adopted Housing Element:** Discussion and possible CIS regarding the “Livable Communities Initiative” (LCI) proposed for “transit-rich corridors” and may include additional incentives and waivers to create multi-family housing. This initiative may include reductions in setbacks, floor area, and other development standards; elimination of parking requirements; minimum density requirements; increased affordability; and encouragement of smaller units to create higher density. There may be some exclusions for certain fire hazard zones, historic districts, and projects that propose demolition of existing affordable housing. It is unclear how this program will or will not enhance, complement, overlap, or expand other incentivizing programs such as TOC, state and local Density Bonus laws, or CPIO affordable housing provisions. The proposed LCI program is now being heard at various City Council committees, including Housing and Transportation, before going to the full City Council for a vote, likely within the next few months. Other NCs have been recently providing CIS’s to provide input on the program. – **DISCUSSION AND ACTION**
- 6). **CPC-2020-2115-DB - 1848 S. Gramercy:** Discussion and possible action of any new developments to the above project, which UNNC has commented on numerous times over the past several years. The case was continued by the City Planning Commission (CPC) in late October and will go before the Commission again in December. No known changes have been made to the project, though there may be changes (significant or not) currently being negotiated between the applicant and the Planning Department. Changes may be revealed at any time and may or may not be significant enough to require an updated action by UNNC. – **DISCUSSION AND ACTION**

Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's or Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board or Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board or Committee meeting. Public comment is limited to 1 minute per speaker, unless waived by the presiding officer of the Board or Committee. At this virtual meeting, when prompted by the presiding chair to provide public input, members of the public will be requested to dial \*9 or use the Raise Hand option on the computer, to address any agenda item before the Committee takes an action on an item.

**Further AB 361 Updates:** Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

The agendas for the UNNC meetings are normally posted for public review at some locations that are currently closed due to the COVID-19 crisis. **Please note:** All UNNC stakeholders are invited to participate in UNNC Standing Committee meetings. UNNC's Governing Board appoints Committee Chairs and Co-Chairs annually; these positions are open to all stakeholders. Per UNNC practice and policy, all stakeholders present at a Standing Committee meeting, including members of UNNC's Governing Board, are considered to be members of that committee for the duration of that meeting, and may equally participate, including by making motions and voting. Any action taken at the meeting is only a recommendation to the Governing Board; no Standing Committee may act on behalf of the Governing Board without prior authorization. UNNC's Governing Board members may be in attendance at its Standing Committee meetings as participants or observers. Per the California Open Meetings Act ("The Ralph M. Brown Act"), in accordance with Government Code Chapter 9 / meetings [54950 - 54963], Section 54952 (b), UNNC's Standing Committees are "legislative bodies" for the purposes of this Chapter. And, in accordance with Section 54952.2. (c) (6), nothing in this section prevents the attendance of a majority of the members of a legislative body at an open and noticed meeting of a standing committee of that body.

### Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service . . ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.
