## **AGENDA**

- 1). **Determination to continue to hold meetings virtually:** *The Board of Neighborhood Commissioners (BONC) and the Department of Neighborhood Empowerment, with guidance from the Los Angeles City Attorney, have established that BONC has the authority to adopt AB 361 Findings Pursuant to Government Code Section 54953(E)(1)(b)-(c) on behalf of the City's neighborhood councils, and to determine that due to the Covid-19 state of emergency, meeting in person would present imminent risks to the health or safety of attendees. This meeting is being conducted virtually pursuant to that directive.*
- 2). **Welcome & Call to Order; Review of UNNC Standing Rules for Committee Stakeholder Voting Participation; Introductions and Voting Affirmations; Review of the Agenda**
- 3). **General Public Comments** (1-2 minutes per speaker)
- 4). **Harvard Adams Housing Partners, LP for affordable multifamily housing project(s):** Presentation / Update regarding City Council File: 22-1292, bond funding for Harvard Adams Housing Partners, LP. The City Council approved supporting the issuance of bonds in an amount not to exceed \$16,000,000 to provide financing for the acquisition, rehabilitation, and equipping of a 48-unit residential housing project at located at two sites, 1938 S. Harvard Blvd. and 4230 West Adams Blvd. The stated goal is to preserve the affordability of the existing housing. The developer / representative will be present to describe the plans, construction scope and the process; and to answer community questions. -- **DISCUSSION AND POSSIBLE ACTION**
- 5). **Discussion of recently passed AB2097 (statewide parking-reduction law):** Assembly Bill 2097 (AB 2097) is a California law prohibiting cities from imposing a minimum automobile parking requirement on most development projects located within a half-mile radius of a major transit stop. This law will potentially have significant impacts in the UNNC area by reducing or eliminating parking requirements for most new development (commercial and residential) as we are in "transit rich" zones and near major transit stops as defined in the law. In Los Angeles, City Planning is responsible for overseeing the implementation of AB 2097. The law is already in effect and is reflected in recent updates to ZIMAS. – **DISCUSSION**
- 6). **Transition to a Permanent Al Fresco:** Presentation on the proposed Permanent Al Fresco Ordinance which would amend Sections 12.03, 12.10.5, 12.11.5, 12.12.2, 12.13, 12.14, 12.21, 12.21.1, and 12.24 of the Los Angeles Municipal Code (LAMC) to clarify and streamline Zoning Code regulations regarding outdoor dining on private property. As proposed, outdoor dining that complies with the applicable standards would be permitted as a by-right use in any zones where restaurants are currently permitted. Any outdoor alcohol service would continue to require compliance with all applicable zoning regulations. Discuss potential Community Impact Statement (CIS) and/or Resolution. – **DISCUSSION AND POSSIBLE ACTION**

Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's or Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board or Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board or Committee meeting. Public comment is limited to 1 minute per speaker, unless waived by the presiding officer of the Board or Committee. At this virtual meeting, when prompted by the presiding chair to provide public input, members of the public will be requested to dial \*9 or use the Raise Hand option on the computer, to address any agenda item before the Committee takes an action on an item.

**Further AB 361 Updates:** Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

The agendas for the UNNC meetings are normally posted for public review at some locations that are currently closed due to the COVID-19 crisis. observers. Per the California Open Meetings Act (“The Ralph M. Brown Act”), in accordance with Government Code Chapter 9 / meetings [54950 - 54963], Section 54952 (b), UNNC’s Standing Committees are “legislative bodies” for the purposes of this Chapter. And, in accordance with Section 54952.2. (c) (6), nothing in this section prevents the attendance of a majority of the members of a legislative body at an open and noticed meeting of a standing committee of that body.

### Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service . . ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.
