**3). Case No. ZA-2023-1767-CUB-CUX, 3020 Crenshaw Blvd.:** Proposed Change of Use from Theater to an Event and Banquet Hall for the purposes of special events, including dancing; and also including a CUB for on-site consumption of a full line of alcoholic beverages within the building. Originally constructed in 1941 as the Crenshaw Theater, it was later an African American-operated theater, then the L.A. Jazz Concert Theater. Later renamed the Kokusai Theater, it is also associated with the influx of the Japanese American community into the Crenshaw district in the post-World War II period. The project also proposes to restore the Kokusai Theatre sign and the theater marquee. Presentation by the Applicant. – **DISCUSSION AND POSSIBLE ACTION**

**4). Case No. PAR-2023-2183-AHRF-ED1, 2225 West Venice Blvd.:** Construction, use, and maintenance of a 43-unit apartment building with 100% of units (exclusive of a manager's unit) set aside for affordable households. Presentation and review of plans. – **DISCUSSION**

**5). FAA NextGen Update - Comment period to the FAA:** UNNC's FAA/Quiet Skies initiative is concerned with the noise from streamlined, low-altitude flight paths directly over the UNNC footprint resulting from the implementation of Nextgen/Metroplex/North Downwind program into LAX since 2017. The FAA, as a result of a successful lawsuit by the City of Los Angeles, is now collecting comments for its study of the effects of noise from the program. UNNC has an opportunity, through its representation at the LAX Community Noise Roundtable, to submit comments that will become part of the Roundtable collective comments, as well as provide independent comment directly from UNNC and/or individually from stakeholders. -- **DISCUSSION AND POSSIBLE ACTION**

Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's or Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board or Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board or Committee meeting. Public comment is limited to 1 minute per speaker, unless waived by the presiding officer of the Board or Committee. At this virtual meeting, when prompted by the presiding chair to provide public input, members of the public will be requested to dial \*9 or use the Raise Hand option on the computer, to address any agenda item before the Committee takes an action on an item.

**Further Brown Act Updates:** Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Per UNNC practice and policy, all stakeholders present at a Standing Committee meeting, including members of UNNC's Governing Board, are considered to be members of that committee for the duration of that meeting, and may equally participate, including by making motions and voting. Any action taken at the meeting is only a recommendation to the Governing Board; no Standing Committee may act on behalf of the Governing Board without prior authorization. UNNC's Governing Board members may be in attendance at its Standing Committee meetings as participants or observers. Per the California Open Meetings Act ("The Ralph M. Brown Act"), in accordance with Government Code Chapter 9 / meetings [54950 - 54963], Section 54952 (b), UNNC's Standing Committees are "legislative bodies" for the purposes of this Chapter. And, in accordance with Section 54952.2. (c) (6), nothing in this section prevents the attendance of a majority of the members of a legislative body at an open and noticed meeting of a standing committee of that body.

### Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service . . ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.

No part of the conversation that takes place between callers is revealed or recorded in written, verbal, or any other form. CRS CAs do not participate in the conversation and acquire no benefit from information relayed.
