- i. Appoint Ad Hoc Bylaws Committee – **DISCUSSION AND POSSIBLE ACTION**
- ii. Discussion of SB 411, state legislation that may allow UNNC to change its meetings to zoom only, or to continue with in-person meetings with hybrid format. City Council adopted an authorizing motion on 11/1/2023, and now each neighborhood council must itself vote, which requires 2/3 vote of the entire board in the affirmative (e.g., 16 board members for UNNC). If approved, for teleconferencing meetings, Board member Zoom attendees must be within the City Limits during the meeting. For in-person meetings, AB 2449 rules apply. The following draft motion incorporates suggested language from DONE as well as the Los Angeles Neighborhood Council Coalition:

*Motion to file a Community Impact Statement (CIS) for Council File 23-1114 and a Board Resolution to authorize the use of teleconferencing for Neighborhood Council meetings, including board meetings and committee meetings, in accordance with the rules established by Senate Bill 411 and the subsequent motion passed by the City Council on November 1, 2023. UNNC's Executive Committee is delegated to select either in-person or teleconferencing (Zoom) for individual Governing Board meetings. Committee chairs, in consultation with the Executive Committee, may also select to utilize either in-person or teleconferencing from time to time. The special teleconferencing rules available to Los Angeles Neighborhood Councils are necessary because they may provide for increased accessibility and increased community engagement, as well as the health and safety of the participants. The Resolution shall be filed as a CIS to notify all Los Angeles City Council members, and copies sent to DONE and BONC. – **DISCUSSION AND ACTION***

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board or a Committee is prevented from acting on a matter you bring to its attention during the General Public Comment period; however, the issue raised by a public member may become the subject of a future Board or Committee meeting. Public comment is limited to 1 minute per speaker unless waived by the Board or Committee presiding officer. When prompted by the presiding chair to provide public input at this virtual meeting, public members who are attending virtually will be requested to dial *9 or use the Raise Hand option on the computer to address any agenda item before the Board takes action on an item.

Further Brown Act Updates: Public comments cannot be required to be submitted in advance of the meeting. Only real-time public comment is required. If broadcasting interruptions prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Telecommunication Relay Services

Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications.

Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user. What forms of TRS are available?

There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TIY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service.

Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service . . ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.

No part of the conversation that takes place between callers is revealed or recorded in written, verbal, or any other form. CRS CAs do not participate in the conversation and acquire no benefit from information relayed.
