1). Welcome & Call to Order; Review of UNNC Standing Rules for Committee Stakeholder Voting Participation; Introductions and Voting Affirmations; Review of the Agenda

2). General Public Comments (1-2 minutes per speaker)

3). Case No. ADM-2024-174-DB-VHCA-ED1, 2075 West Jefferson (corner Arlington): Construction of a new 100% Affordable 51,655 sq. ft., 6-story, 71'6" tall, 100-unit apartment building. ED-1 administrative case (79 low income, 20 moderate income, one manager unit) but located within Jefferson Park HPOZ. Actual zoning is C2-1VL-O-HPOZ-CPIO (height district = “very low”). This application falls under the Mayor’s Emergency Order No. 1 for affordable housing, but may also need to meet HPOZ preservation plan standards. It is also located within the Mid-City Corridors Redevelopment Plan. This agenda item is **DISCUSSION ONLY**.

4). Initial Review of Case. No. ZA-2024-218-CUB, 1874 S. Western (7-11): Proposed CUB to allow off site beer & wine sales in conjunction with existing 7-11 having 24-hour daily operations. Prior 2014 approval Determination Letter required Applicant to keep premises and parking lot free of litter and nuisance activities. Applicant representatives may not be present at this meeting. – **DISCUSSION AND POSSIBLE ACTION**

5). Processes and Procedures Ordinance Presentation: Starting January 22, 2024 all new applications will be subject to the Processes and Procedures Ordinance. The Processes and Procedures Ordinance is the first component of a larger initiative to comprehensively update the City’s Zoning Code. We will briefly explain (among the changes) some of the new regulations that appear to affect UNNC the most, including: Neighborhood Councils will officially be notified of case filings and hearings; the Appeals process is changed to provide “de novo” review of the original case; CEQA appeal procedures are clarified; project “vesting” is clarified; and there are some changes related to Specific Plans (including HPOZs). Redevelopment Plans were inadvertently left out of the Ordinance, and this is being corrected. – **DISCUSSION**

6). Initial Review, Case. No. CPC-2023-8134-DB-CU-CCMP-SPR-HCA, 1828-1830 S. Western: Proposed 6-story, 189-unit, 175 parking spaces, over 1-level commercial mixed use development. Based on the set-aside of 25 percent of base units for Very Low Income (VLI) households, applicant is entitled to 3 Incentives under both the Government Code and LAMC. Plans show the building set back with a street dedication on Western. At previous community meetings concerns were raised regarding the proposed demolition of the rear building, the former Ross Medical Annex doctors’ offices. A subsequent historical evaluation was prepared but is not attached to public documents. Applicant representatives may not be present at this meeting. -- **DISCUSSION**

Comments from the public on other matters not appearing on the agenda that are within the Board's or Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board or Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board or Committee meeting. Public comment is limited to 1 minute per speaker, unless waived by the presiding officer of the Board or Committee. At this meeting, when prompted by the presiding chair to provide public input, members of the public who are attending virtually will be requested to dial *9 or use the Raise Hand option on the computer, to address any agenda item before the Committee takes an action on an item.

Further Brown Act Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Per UNNC practice and policy, all stakeholders present at a Standing Committee meeting, including members of UNNC's Governing Board, are considered to be members of that committee for the duration of that meeting, and may equally participate, including by making motions and voting. Any action taken at the meeting is only a recommendation to the Governing Board; no Standing Committee may act on behalf of the Governing Board without prior authorization. UNNC's Governing Board members may be in attendance at its Standing Committee meetings as participants or observers. Per the California Open Meetings Act ("The Ralph M. Brown Act"), in accordance with Government Code Chapter 9 / meetings [54950 - 54963], Section 54952 (b), UNNC's Standing Committees are "legislative bodies" for the purposes of this Chapter. And, in accordance with Section 54952.2. (c) (6), nothing in this section prevents the attendance of a majority of the members of a legislative body at an open and noticed meeting of a standing committee of that body.

Telecommunication Relay Services: Telephone communication is one of the most important forms of communication in society today. Due to advancements in technology, telephone devices have evolved with new services and capabilities. Individuals who are deaf and hard of hearing, and individuals with a speech disability are following these trends and are rapidly migrating to more advanced telecommunications methods, both for peer-to-peer and third-party telecommunications relay service (TRS) communications. Telecommunications Relay Service is a telephone service that allows persons with hearing or speech disabilities to place and receive telephone calls. TRS is available in all 50 states, the District of Columbia, Puerto Rico and the U.S. territories for local and/or long distance calls. TRS providers – generally telephone companies - are compensated for the costs of providing TRS from either a state or a federal fund. There is no cost to the TRS user.

What forms of TRS are available? There are several forms of TRS, depending on the particular needs of the user and the equipment available: TRS includes: Text to Voice TTY-Based TRS; Speech-to-Speech Relay Service; Shared Non-English Language Relay Service; Captioned Telephone Relay Service; Internet Protocol Relay Service; and Video Relay Service. Don't hang up! Some people hang up on TRS calls because they think the Communications Assistant (CA) is a telemarketer. If you hear, "Hello. This is the relay service . . ." when you pick up the phone, please don't hang up! You are about to talk, through a TRS provider, to a person who is deaf, hard-of-hearing, or has a speech disability.

If you have limitations hearing or speaking a specially-trained CA can relay telephone conversations for all of your calls. In California, dial 711 to reach the California Relay Service (CRS). If you prefer having your calls immediately answered in your mode of communication, dial one of the toll-free modality- and language-specific numbers below. The call will be routed to the CRS provider.

No part of the conversation that takes place between callers is revealed or recorded in written, verbal, or any other form. CRS CAs do not participate in the conversation and acquire no benefit from information relayed.
